### BC/7 (PIC) – Erosion of Compassion

Ven. Dr Wayne Brighton sought leave to bring BC/7 in an amended form. (*Leave granted*).

**Motion:** The Anglican Church of Australia covers a broad section of the community. It is observed that current Federal leaders are preoccupied with internal matters and disconnected from the communities they represent. Consequently, this Synod:

1. affirms the Christian values of kindness, compassion and the intrinsic value of each person;
2. laments that kindness, compassion and treating people with dignity are being eroded in our society, as we see, for example, in:
  - a. treatment of some asylum seekers and refugees resulting in significant physical and mental health problems and the separation of families;
  - b. persistent inequality and the winding back of income safety nets;
  - c. fear-mongering and division, instead of on fostering social harmony and unity; and
  - d. policies that undermine the capacity of charities to speak out against wrongs;
3. asks the Vicar General to write to the leaders of all parties currently represented in the Commonwealth, New South Wales, and the Australian Capital Territory parliaments advising them of 1 and 2 and asking them to have kindness, compassion and the innate dignity of each person guide their policies, decision-making, and behaviour;
4. asks the Public Issues Commission to produce a series of conversation resources, along the lines of 'Being Christ's Body', on Christian attitudes to issues such as the above.

### **BC/8 (PIC) – Changing Climate**

Bishop Stephen Pickard sought leave to bring the motion to Synod in an amended form. *(Leave granted).*

**Motion:** That this Synod:

1. notes that the changing climate, with the disrupted weather patterns and rising sea levels, is impacting the frequency and intensity of problems, including extreme weather, drought, bushfires, storms and floods, economic difficulties, and increasing problems with mental and physical health; and that the most vulnerable are at most risk;
2. mourns the changes we observe and expect in our natural world and life as we know it

3. acknowledges the sorrow, distress, suffering, losses, and hardship that these changes are causing;
4. celebrates that, during times of great challenge or transformation, our religious tradition and faith communities have been and continue to be important sources of inspiration and support;
5. encourages parishes and ministry units to draw on courage, hope, wisdom and spiritual reflection and demonstrate the love of God and care for creation by working with their communities to:
  - a. prepare for and deal with the impacts from our changing climate and associated grief and emergencies; and
  - b. build greater resilience to these impacts;
6. asks the Public Issues Commission to publicise resources to Diocesan ministry units that may help with this work.

### **BC/9 (PIC) – Acknowledgement of Aboriginal Peoples**

Ven. Dr Wayne Brighton sought leave to bring the motion to Synod in an amended form. (*Leave granted*).

**Motion:** That this Synod recognises that 2020 will be the 250<sup>th</sup> Anniversary of Cook's claiming of the lands of this Diocese in the name of the King. This presumed sovereignty has led to a profound and ongoing experience of dispossession, trauma, grief, and disadvantage for the traditional owners of this country we now call Australia.

In light of this:

1. encourages parishes to study the Uluru Statement (readable at <https://www.clc.org.au/files/pdf/Uluru-Statement-3.pdf>) and to consider, in the light of the Government's rejection of the Statement, whether individuals may wish to raise the issue with their local Member of Parliament;
2. encourages parishes to include in their entry signage a simple statement such as 'We acknowledge that this church building rests on Aboriginal land' or, where the local Aboriginal group is clearly identifiable, an acknowledgement that includes the name of that group instead of the blanket term 'Aboriginal';
3. asks the Public Issues Commission to prepare some liturgical materials (such as the Lord's Prayer) in some of the Aboriginal languages of the Diocese.

## BC/10 (PIC) – Inequality

**Motion:** That this Synod:

1. affirms that when we pray ‘your Kingdom come, your will be done on earth as it is in heaven’, this is not only a personal prayer but a prayer for our world because:
  - a. we believe each human being is made in God’s image and likeness;
  - b. we pray that we may ‘share with justice the resources of the earth’; and
  - c. the Bible reminds us that how we treat the hungry, the thirsty, the stranger, and the prisoner is how we treat Christ himself;
2. responds to God’s call for us to protect and seek justice for those who are poor and vulnerable;
3. requests the Vicar-General write to the Prime Minister and the Leader of the Opposition asking them to:
  - a. give renewed priority to reducing poverty for the ~~growing~~ persistent number of Australians who are deprived of the basic opportunities, resources and amenities required to participate in society and to afford the basic necessities;
  - b. end political commentary that seeks to scapegoat groups of immigrants and refugees in our community and immediately end the disgraceful treatment of ~~refuges~~ refugees and asylum seekers on Nauru that shames our nation;
  - c. increase the real rate of unemployment payment (Newstart Allowance), which has not been increased for two decades and leaves more than 750,000 Australians struggling to pay for essentials;
  - d. join in a public discussion on a universal basic income in recognition of the persistent high levels of youth unemployment (three times the average), the lack of entry level jobs where ~~your~~ young people can gain experience, and the increasing use of automation in the workplace;
  - e. act to protect workers from exploitation in the so-called ‘gig’ economy where digital platforms support flexible work arrangements that often see the workers lose their protections including basic legislated minimum wages, workers compensation and superannuation.
