

# Sound skills for solid servant leadership

St Mark's **Diploma of Leadership and Management (BSB51918)** is government-accredited and offers a broad range of leadership skills, equipping church ministers and leaders with the confidence, tools, and knowledge to survive and thrive in the increasingly demanding role of Church leadership.

The course offers a balance between elements of personal development and reflection, communication and relationship building, as well as practical skills such as financial management and marketing. This qualification will complement ministry training and theological studies, providing skills for developing and maintaining vibrant and diverse ministry teams, while also providing skills to support personal wellbeing in order to cope with the demands of leadership over the longer term.

Graduates may be eligible to pursue further training via the Advanced Diploma of Leadership and Management (BSB61015) or other Advanced Diploma qualifications. Graduates may also receive articulation into a related degree level course, including credit for one unit (8 points) in the CSU Master of Ministry articulated set (including Grad Cert and Grad Dip), or credit for four units (32 points) in the CSU Bachelor of Business.

## UNITS OF COMPETENCY

Competencies in this course are taught using a highly integrated approach within four Modules. All Modules, including units of competency covered in each, are outlined below.

#### 1 FFFECTIVE COMMUNICATION

Learn to negotiate and present persuasively, share ideas, manage meetings and resolve relationship issues. Develop a practice of reflection on one's own emotional strengths and weaknesses, and similarly respond and support others in this practice.

- Develop and use emotional intelligence (BSBLDR511)
- Lead and manage effective working relationships (BSBLDR502)
- Communicate with influence (BSBIDR513)

#### 2 MANAGING RISK AND SAFFTY

Understand legal safety compliance requirements in relation to people and property, and implement responses to risks facing ministry or workplace situations. Understand and implement the requirements of safe ministry processes, including development of personal practice, to ensure own leadership and ministry actions supports safe communities.

- Ensure a safe workplace (BSBWHS501)
- Manage risk (BSBRSK501)
- Reflect on and improve own professional practice
  (CHCPRP003)

#### 3. PLANNING AND RESOURCING

Develop and implement operational and mission plans using a variety of information sources and consultation. Develop practical skills in marketing and financial management, and integrate sound governance into operational planning and processes.

- Manage operational plan (BSBMGT517)
- Implement and monitor marketing activities (BSBMKG514)
- Manage finances (BSBFIM601)

#### 4 IFADING AND BUILDING TEAMS

Establish processes which encourage the development of individuals to facilitate team cohesion and collaborative ministry outcomes. Use effective communication skills to give feedback and develop others.

- Develop a workplace learning environment (BSBLED501)
- Lead and manage team effectiveness (BSBWOR502)
- Build and sustain an innovative work environment (BSBINNS02)

## MODE AND COURSE DURATION

This is a 2-year part-time course. The course is conducted online with an optional one-day classroom-based training session per Module in Canberra. Students will need access to an environment where they can undertake practical leadership exercises.

Students may enrol in a single Module or the full course.

## ADMISSION REQUIREMENTS

Candidates for the Diploma of Leadership and Management need to:

- have achieved a level of education equal to or above Australian Year 10 certificate.
- have sufficient literacy skills to read and engage with complex material and other literature related to leadership and management.

## Applicants also need to EITHER

- provide evidence they hold a current leadership role in their church or organisation, OR
- provide a letter of support from a church minister or other manager indicating agreement for practical leadership assessment activities to be undertaken in their church or other organisation.
